American Board of Allergy and Immunology	<ul style="list-style-type: none"> • Complete 25 AMA PRA Category I credits™ annually. • Complete a communication module once every 10 years. • Complete a patient safety module once every 10 years. • Complete a Recent Advances Module once every 5 years. 	www.abai.org
American Board of Anesthesiology	<ul style="list-style-type: none"> • All credits must be AMA PRA Category I credits™. • No more than 70 CME credits per calendar year (completed between 2006 and 2012) will be credited toward the Part II requirement. • No more than 60 CME credits per calendar year (completed in or after 2013) will be credited toward the requirement. • Complete a minimum of 20 AMA PRA Category I credits™ from ABA-approved Patient Safety CME Activities. 	www.theaba.org
American Board of Colon and Rectal Surgery	<ul style="list-style-type: none"> • Complete 90 AMA PRA Category I Credits™ every five years. • Over a five-year cycle, 50 of the 90 AMA PRA Category I Credits™ must include a self-assessment activity. CARSEP or SESAP are recommended, however, any accredited CME activity that provides AMA PRA Category I credits™ and a self-assessment component (with a passing score of greater than 75%) will be accepted for MOC Part II Self-Assessment. 	www.abcrs.org
American Board of Dermatology	<ul style="list-style-type: none"> • Attest to having earned a minimum of 25 AMA PRA Category I Credits™ annually. • A foundational patient safety course or equivalent learning experience must be performed only once in a diplomate's career, either before or within the first two years of MOC participation, • Complete a minimum of 100 self-assessment questions in each of these 3 periods; years 1-3, years 4-6 and years 7-10. 	www.abderm.org
American Board of Emergency Medicine	<ul style="list-style-type: none"> • Complete four ABEM Lifelong Learning and Self-Assessment (LL-SA) tests during the first five years and during the second five years of the diplomates' 10-year certification cycle. • Complete an average of 25 AMA PRA Category I Credits™ annually. 	www.abem.org
American Board of Family Medicine	<ul style="list-style-type: none"> • Complete 150 CME credits of specialty-relevant CME every three years. A minimum of 75 of the 150 CME credits must be AMA PRA Category I Credits™. • Complete a minimum of one Knowledge Self-Assessment Activity (KSA) every three years. Successful completion of a KSA earns 10 ABFM MOC Points and 8 AMA PRA Category I Credits™. ABIM Board Certified physicians must earn 100 points every five years, 20 of which must be in Medical Knowledge. ABIM and the Accreditation Council for Continuing Medical Education (ACCME) are collaborating to support physicians who are engaged in lifelong learning by enabling them to earn MOC points for Continuing Medical Education (CME) that they are already doing. 	www.abim.org
American Board of Medical Genetics and Genomics	<ul style="list-style-type: none"> Complete one online literature review module every three years, or three within a 10-year cycle. Complete one patient safety activity per 10-year cycle. Complete 250 AMA PRA Category I (or equivalent) CME credits throughout the 10-year cycle. At least 50% of the CME credits must be related to Medical Genetics and Genomics. 	www.abmg.org
American Board of Neurological Surgery	<ul style="list-style-type: none"> Complete 150 CME credits each mini-cycle (every three years). 60 of the 150 CME credits must be AMA PRA Category I Credits™ and relevant to Neurosurgery. Complete one Patient Safety course each mini-cycle (every three years). Complete a minimum of the ABNS approved Self-Assessment in Neurosurgery Activity (SANS) every three years. 	www.abns.org
American Board of Nuclear Medicine	<ul style="list-style-type: none"> Complete a minimum of 25 AMA PRA Category I Credits™ annually, which includes a minimum of 17.5 AMA PRA Category I Credits™ relevant to Nuclear Medicine. Eight self-assessment credits must be part of the 17.5 CME credits related to Nuclear Medicine. Self-Assessment credits are awarded for both self-assessment modules (SAM's) and Self-Assessment CME activities. 	www.abnm.org
American Board of Obstetrics and Gynecology	<ul style="list-style-type: none"> Complete 30 practice-relevant journal articles and complete 4 post-assessment questions per journal article. Complete a minimum of 120 post-assessment questions annually. ABOG delivers the journal-based assignments during the first week of January, April and July annually. Achieve an 80% completion rate on the 120 post-assessment questions (minimum) and submit by due date. Upon successful completion of the ABOG reading assignments and post-assessment questions diplomates will earn 25 AMA PRA Category I CME™ credits from ACOG. American Board of Ophthalmology	<ul style="list-style-type: none"> Complete an average of 25 AMA PRA Category I CME Credits™ annually. 80% of the total 250 AMA PRA Category I Credits™ (10-year cycle) must be relevant to Ophthalmology. Track 2 diplomates are asked to acquire an average of 25 Category I CME credits per year, including 8 Self-Assessment (SA) credits. As of 2017, Periodic Ophthalmic Review Tests (PORTs) modules are optional self-assessment activities for all diplomates (not required for the completion of MOC). SAE are activities produced by organizations other than the ABOS, then approved for MOC credit by ABOS.
